¹ In 2017, the ACA expanded Medicaid eligibility to most people with income up to 133% of the federal poverty level (FPL). However, in addition to new income counting rules for most Medicaid populations (called "Modified Adjusted Gross Income"), there is an additional 5% disregard of income, effectively bumping the Medicaid income eligibility threshold to 138% FPL.

² In Alabama, Part B/ADAP eligibility increased from 300% FPL to 400% FPL on April 1, 2017.

³ In Alaska, Medical Case Management is capped at 650% FPL.

⁴ In Illinois, there is no income eligibility limit for Medical Case Management.

⁵ In Maine, Medical Case Management is capped at 500% FPL. Oral Health Care is capped at 300% FPL.

⁶ In Maryland, Part B eligibility increased from 400% FPL to 500% FPL on July 1, 2017.

⁷ In Utah, Medical Case Management and Non-Medical Case Management is capped at 500% FPL.

⁸ In Virginia, Part B/ADAP eligibility increased from 400% FPL to 500% FPL on July 1, 2017.
